- 1. Duly filled and signed Visa Application Form
- 2. One 2 x 2 recent photo
- 3. PASSPORT (valid for 6 months from date of entry to Egypt)
- 4. FEE -\$ 15 per passport for US Citizen in CASH or Money order from USPS payable to Egyptian Consulate. Personal, company checks, or credit cards are not acceptable.
 - For other nationalities, please contact the Consulate for fees and other requirements.
- 5. For Non-American, photocopy of greencard and round trip ticket or itinerary.
- 6. For Business Visa a letter from the company stating purpose of the trip and financial guarantee of the company.

APPLICANTS BY MAIL:

Send the above requirements (we need the original passport) with a self-addressed-stamped-envelope for the return of passport/s. If sending via USPS- e.g. Express Mail, Priority Mail with confirmation, please send proper postage. Do not send metered stamps. Couriers e.g. Airborne, DHL, Fedex with company accounts are acceptable. WE DO NOT ACCEPT CREDIT CARD ACCOUNT NUMBERS.

IMPORTANT NOTICE:

- CUSTOMS DECLARATION There is no limit on the amount of currency which the visitors may bring to Egypt, however, they must declare the currency and amount on Form D upon arrival and departure with bank receipts. If you are carrying **Egyptian Currency**, it should not exceed 5,000 L.E.
- HEALTH CERTIFICATE Required only if traveler is coming from an infected area.
- VALIDITY Tourist visas are valid for 6 months from date of issue. Business visas are valid for 3 months from date of issue.
- WORK Holders of tourist visas are not allowed to work in Egypt.
- PROCESSING TIME American applicants who come personally will be processed on the same day. By mail is 5 10 working days, excluding mailing time.
 - Incomplete requirements will delay the visa process.
